#### **Everyday Discrimination**

Positive predictor of alcohol use after controlling for potential confounders  $(OR = 1.06, 95\% \ Cl = 1.04 \text{ to } 1.08)$ 

#### Friend Confidant Support

Positive predictor of alcohol use after controlling for potential confounders  $(OR = 1.14, 95\% \ Cl = 1.07 \text{ to } 1.22)$ 


